This statement is in response to your request whether our products contain Substances of Very High Concern (SVHC) in view of UK REACH. For your information, Under the European Union (Withdrawal) Act 2018, the EU REACH Regulation was brought into UK law on 1 January 2021 and is known as UK REACH. UK REACH regulates chemicals placed on the market in GB. Under the terms of the Northern Ireland Protocol, EU REACH continues to apply in Northern Ireland.

The Substances of Very High Concern are identified in the "UK REACH Candidate list" (referred to in Article 59 of the authorization system) and gradually they may be included in Annex 14 (UK REACH Authorization List) of the UK REACH.

We hereby certify that the here above mentioned products do not contain more than 0.1% (w/w) of any substance of very high concern listed in the UK REACH Candidate List published in accordance with Article 59(10) of UK REACH, as updated on **June 25th, 2020**.

However, since we do not perform specific tests to verify the potential presence of SVHC in our Product(s), we cannot guarantee that there is no trace amount of some of SVHC, as impurity or otherwise, in our Product(s).

Our letter does not cover :

- any modification of The Product by any addition of any other product to it,
- any prejudicial modification of The Product resulting from a processing of The Product,
- an inadequate use and/or storage of The Product and of the finished articles.

The present letter is valid as long as the UK REACH Candidate list has not been updated.
